Troescher](#): Article from the Spotlight announcing U.S. v Troescher, No. 95-55609, a case in which the Ninth Circuit Court of Appeals agreed with Mr. Troescher's Fifth Amendment defense against producing books and records, stating clearly that there was no "Tax Crime Exception" to the Fifth Amendment -- a severe blow to IRS "tax crime" prosecutions. Court's findings also posted.
 - [Dr. Phil Roberts](#). Refused to submit tax returns for two years to preserve his Fifth Amendment rights not to testify against himself. Trial held in 8th Circuit court, Arkansas, and prosecuted by SIX government attorneys. He was not allowed to present witnesses or evidence or appear at trial and was railroaded into either confessing or going to jail. Eventually, arraigned and sentenced to 3.5 years in federal prison for a misdemeanor violation of the tax code (26 U.S.C. 7203, "Willful Failure to File a Tax Return"), and became another one of this nation's political "tax" prisoners. Don't kid yourself, America is NOT a free country. This should not be allowed to happen, but is an obvious scare tactic by the government to keep people filing.
